### WHAT IS CM/ECF?

[CM/ECF stands for “Case Management/Electronic Case Files.”](#) CM/ECF is the automated case management and electronic docketing system for the U.S. Bankruptcy Court for the District of Maryland. CM/ECF provides an easy-to-use electronic case filing feature that makes life easier for you by allowing you to file and view court documents over the internet.

#### How Does it Benefit You?

CM/ECF will allow users to file and view documents from their office, home or anywhere they have access to the Internet, 24 hours a day. Documents are automatically docketed as part of the filing process and are immediately available electronically. CM/ECF also provides the following benefits:

- Automatic e-mail notice of case activity.
- The ability to download and print documents directly from the court system.
- Concurrent access to case files by multiple parties.
- Secure storage of documents.
- Potential reduction in courier fees and copy costs.

### **How Does it Work**

The electronic case filing system accepts documents in a portable document format (PDF). PDF retains the way a document looks when viewing it across different platforms, so the pages, fonts and other formatting are preserved. Filing a document with the court's CM/ECF system is quite easy:

1. Create the document using word processing software or by using your bankruptcy preparation (case upload) software.
2. Save the document in PDF format.
3. Log onto the court's CM/ECF system, using a court-issued login and password.
4. Follow the set of simple prompts to provide information about the case, party and document to be filed.
5. Attach the PDF document and submit it online to the court for filing.
6. Save or print the CM/ECF electronic receipt e-mailed from the court confirming that the document was filed.

### **What Does it Cost?**

There are no added fees for filing documents over the Internet using CM/ECF; existing document filing fees still apply. Electronic access to court data is available through the Public Access to Court Electronic Records ([PACER](#)) program. You receive one free copy of documents filed electronically in your cases, when you receive electronic notice. Additional copies are available for viewing or downloading. Visit the PACER web site to register and for updates on their fees and billing information.

Electronic filing is mandatory in the US Bankruptcy Court for Maryland, as described in [Administrative Order 11-03](#).

## **ACCESSING CM/ECF**

The CM/ECF system is a web-based software program. CM/ECF allows attorneys and other public users to submit pleadings for filing and view case data from the internet. Two sets of logins and passwords are required for Internet users (Attorneys, U.S. Trustee, Trustees, and authorized Creditors):

1. [CM/ECF](#) – Allows for the filing of documents.
2. [PACER](#) (Public Access to Electronic Records) – Allows access to case information and reports.

The client code field is an option used by PACER users to associate an activity to specific client(s). All users are personally responsible for the activity with their logins. CM/ECF participants have access to maintain their password, their mailing and e-mail addresses.

CM/ECF attorney registered users must subscribe to electronic notification. Notices can be monitored throughout the day or by requesting a daily summary of activity. Every attorney user can access a copy of the document that has been filed one time without charge. It is advisable to save or print this document. Subsequent requests through the document's hyper link will take the user directly to the PACER login screen.

## **PACER – PUBLIC ACCESS TO ELECTRONIC RECORDS**

PACER is an electronic public access service that allows users to obtain case and docket information from federal appellate, district, and bankruptcy courts, and the PACER Case Locator via the internet. PACER is provided by the federal Judiciary in keeping with its commitment to providing public access to court information via a centralized service.

## **COMPUTER REQUIREMENTS AND RECOMMENDATIONS**

### **Personal Computer Running Windows/Macintosh**

Recommendations:

- Pentium III or greater w/64MB of RAM
- 1 GB Free Disk Space
- 17" Color Monitor
- Scanner to convert documents that you did not create into PDF/A format.

### **Internet Service Provider**

Recommendations:

- Cable Modem, DSL, ISDN or T1
- Dial-up access can be used but file upload times will be longer

### **Browser**

Recommendations:

- Microsoft Internet Explorer 6.0 or higher
- Firefox 3.6.17

### **PDF/A Conversion Software**

Recommendations:

- Adobe Acrobat v. 8 or higher to provide document conversion from word processing or petition software to Portable Document Format (PDF/A). Scanners (used for non-attorney prepared documents) must be able to scan PDF/A.



## YOUR ECF ACCOUNT



### CHANGING YOUR PASSWORD

#### Change Your CM/ECF Password

1. Login to CM/ECF
2. Click 'Utilities'
3. Click 'Change Your Password'
4. Type in your new password twice (minimum of 8 characters, upper- & lower-case letters; include digits or special characters)

#### Change Your PACER Password

1. Login to PACER
2. Under maintenance click 'Change Account Password'
3. Enter the current password
4. Enter the new password and the same password in the 'Confirm' field
5. Click 'Submit'

### FILING AGENTS

The Filing Agent feature in ECF allows an attorney or trustee user to have multiple sub-accounts (users) who can file on their behalf.

## **INTERNET CREDIT CARD PAYMENTS**

Payment of filing fees are completed interactively via the internet credit card program - [Pay.gov](#). Filing fees may be paid within your filing session via a credit card or debit card.

When filing any document requiring filing fees you will receive a screen with a message regarding the filing fee (with the exception for filing a new petition.) How you answer the question will determine if there is filing fee due.

**NOTE:** You must disengage any popup blockers **or** add uscourts.gov as an exception to your browser.

**1. After the final docket text displays, the credit card program will engage with a new pop-up window on your screen.**

- A Summary of current charges appears, displaying the date incurred, description and amount of each filing fee
- To complete the credit card transaction, click Pay Now

**2. The Enter Payment Information screen displays:**

- The card holder name, address and zip code will be retrieved from your CM/ECF account and copied in the appropriate fields. These fields are mandatory and if they are not correct, please click on Utilities from the CM/ECF Menu Bar. Select Maintain Your ECF account and modify as appropriate.
- All other fields with an asterisk are required
- Click 'Continue' to validate the credit card information

**3. The Payment Summary and Authorization Screen displays:**

- Check the Authorize box
- Click 'Make Payment', when the transaction is complete you will have the opportunity to print a receipt of the transaction

**4. Payment of Installments:**

- If you indicated the debtor is paying the petition filing fee in installments

- The installment payment may be paid with the attorney's credit cards. However it must not be paid with the debtor's credit card

#### **5. Paying Filing Fees Due after Closing out of ECF:**

If you logged out of the session without processing your credit card payment, you must log back in and process payment.

- Click 'Utilities'
- Click 'Internet Payments Due'

#### **6. See Steps 1 & 2 for instructions on submitting credit card information.**

## **INTERNET PAYMENTS DUE/HISTORY**

### **Internet Payments Due**

- Click 'Utilities' on the Blue Menu Bar
- Click 'Internet Payments...'
- Click 'Internet Payments Due'
- Select the outstanding fee(s) you want to pay, click 'Next'
- Click 'Pay Now'
- Fill in the 'Online Payment Screen'
- If there are no outstanding fees you will see 'No outstanding fees found!'

### **Internet Payment History**

The Internet Payment History Report allows an attorney to review his/her completed credit card payments over any specified time period. The case number and the receipt number, which should be the same as the transaction number on your credit card statement are shown and this information should assist you in reconciling your credit card charges to your client.

The default for this report is set for the previous 30 days.

- A report of all payments made during the specified time range is displayed

### ASSIGNMENT OF CLAIM

Claims can be assigned electronically using the following steps:

1. Under Bankruptcy, select "Claims: Other Actions."
2. Enter or verify the bankruptcy case number.
3. Select "Assignment of Claim" as the event type.
4. Select the party filer. If the correct party is not listed, select "Add/Create Party" and follow the instructions to add the new party to the case.
5. Browse and attach your PDF.
6. The transfer type screen will display.

**IMPORTANT:** The assignor or transferor (seller) is the creditor making the transfer. The assignee or transferee (purchaser) is the creditor to whom the assignment is being made.

- a. Select the appropriate radio button for the transfer type.
- b. Select the Name of the Purchaser (Transferee, Assignee).
- c. If the Purchaser is not found, Click "Add New Creditor." Type the name and address of the creditor in the box and click "Submit."
- d. Click "Search Creditors" and select the name of the Seller (Transferor, Assignor).
- e. Click "Next" to continue (or continue adding additional claims by clicking "Search Creditors).

- f. Click “Transfer More Claims” if you have more than the additional 2 (3 total) provided.
7. Fee \$25 – Click ‘Next’ menu.
8. Modify the docket text if needed using the drop down menu.
9. The final approval screen displays. Verify the docket text before submitting.

## CLAIMS REGISTER

To access the Claims Register:

1. **Select “Reports” on the blue menu.**
2. **The PACER screen displays.**  
Enter your PACER login, password, client code (if desired) and login.
3. **Select the “Claims Register” hyperlink.**

The 'Claims Register' report may be generated from the 'Report' hyperlink on the CM/ECF Blue Menu Bar.

## STEPS

1. **Click 'Query' or 'Reports' on the Blue Menu**
2. **The Pacer Login screen displays:**
  - Enter your PACER login and password, and a client code, if desired
  - Click Login
3. **The Reports or Query screen displays:**
  - Select the 'Claims Register' hyper link
4. **The Claims Register information screen displays:**
  - Claim Register information can be requested by and limited by:
    - a. Case Number, (a required field),
    - b. Creditor Type,
    - c. Creditor Number,
    - d. Creditor Name,
    - e. Claim Number or Number Range,
    - f. Filed or Entered Date or Date Range

- To view all claims activity for a case, enter only the case number
- Click 'Run Report'

**5. The Claim Register screen displays:**

- The Case number and Case Title, provides a hyper link to the docket sheet
- Case information such as the Office, Trustee, Judge and Flags is displayed
- Last Date to File Claims (other than government)
- Last Date to File (Gov't) Governmental claims

**6. Each Claim listed will contain:**

- Name of the Creditor with a hyper link for Creditor “History”
- Claim No.
- Filed Date
- Date Entered
- Amended Claim No. if amended
- Status: Expunged, Disallowed, Withdrawn, etc. (with hyper link to document)
- Filed by: Creditor, Debtor, Trustee, etc.
- Entered by: (person who entered the claim on the record)
- Modified: (date modified)
- Types of Claim: (Secured, Priority, etc and Amount)
- Total amount claimed
- History: History of the creditor
- Claimant History: History of creditor changes
- The Claim Number is a hyper link to the claim and any supporting attachments
- Hyper link to Document numbers to any Motions/Objections concerning the claim
- A Claims Register Summary displaying the total amount claimed in each category and the total amount of all the claims.

**7. The PACER Service Center Transaction Receipt will show your PACER Login, Description, Case No., Billable Pages and cost.**

## CREDITOR MAINTENANCE

### Adding a Creditor

There may be an instance when a creditor will not appear on the list, if so, that creditor will need to be added to the case in order to file a proof of claim.

1. **Click on 'Bankruptcy' on the Blue Menu Bar**
2. **Click on 'Creditor Maintenance'**
3. **The Creditor Maintenance screen displays:**
  - Click on 'Enter individual creditors'
  - Enter the case number in yy-nnnnn format
  - Click 'Next'
4. **The Add Creditor screen displays:**

**NOTE:** Name may be 50 characters (including blank spaces). Address may be 5 lines, 40 characters each (including blank spaces). More than one creditor may be entered. Separate creditors with a blank line.

  - Enter the Name and Address information of the creditor you are adding on the appropriate lines, as if you were addressing an envelope. See note above for information on adding additional creditors
  - The 'Type' defaults to 'Creditor'
  - Click the down arrow to select a different creditor type, if appropriate
  - If the creditor is a member of the Creditor Committee
  - Click the 'Yes' button
  - Click 'Next'
5. **The Add Creditor(s) screen displays:**
  - Confirm the number of creditors added to the case is correct
  - Click 'Submit'
6. **The Creditors Receipt screen displays:**
  - Confirm the correct Case number and number of creditors have been added to the database
  - Select one of the following screens to proceed:
    - File a Proof of Claim and continue filing a proof of claim, or
    - Return to Creditor Maintenance to continue creditor processing

### **Upload a List of Creditors**

1. Click 'Bankruptcy' on the CM/ECF Main Menu bar.
2. Click 'Creditor Maintenance.'
3. The Creditor Maintenance screen displays.
4. Click 'Upload a List of Creditors File.'
5. Enter a case number and click 'Next.'
6. Click the 'Browse' button and locate the text file you created. See the page on creating a matrix text file.
7. Click 'Next' and then check to be sure the number of creditors matches the number on the list.
8. Click 'Submit.'

### **Edit Creditor (This option is only available for CM/ECF users with an attorney log in)**

1. Click 'Bankruptcy', then 'Creditor Maintenance.'
2. Click 'Edit Creditors.'
3. Enter the name of the creditors' last name or business, or
4. Click 'Next' to select the name from the entire list.
5. The radio button defaults to 'Edit Creditor.'
6. Enter the correct information.
7. Select the appropriate creditor type from the drop-down menu.
8. Creditor committee radio defaults to 'N;' do not change.
9. Click 'Submit.'

### **CREDITOR'S REQUEST FOR NOTICE: and Request for Notice by an attorney not admitted to practice in the USDC**

This event is not to be used by an attorney who is admitted to practice in the U.S. District Court for the District of Maryland. (Admitted attorneys refer to the Notice of Appearance and Request for Notice Module for complete instructions.)

## STEPS

- 1. Click 'Bankruptcy' on the Blue Menu Bar:**
  - Click Miscellaneous
- 2. The Case Number screen displays:**
  - Type the case number in yy-nnnnn format
  - Click 'Next'
- 3. The Available Events List screen displays:**
  - Scroll down to 'Creditor Request for Notices' or type any part of the event name in the search window to narrow the list. The search is not case sensitive.
  - Select the correct event. The event will then show in the 'Selected Events' window. (If you select the incorrect event, click in the 'Selected Events' window to remove it.)
  - Click 'Next'
- 4. The Party Selection screen displays:**
  - The search results screen displays. Scroll through the list of parties, if your party is found, highlight the name and if the name of the party is not found
  - Click 'Create New Party' (Refer to Add/Create New Party for complete instructions).
- 5. Select the Party screen will appear:**
  - Select the party or parties
  - Click 'Next'
- 6. The PDF Document Selection screen displays:**
  - Click 'Browse', (Refer to Navigating through Directories for complete instructions).
  - Click 'Next'
- 7. The Modify Docket Text screen displays:**
  - Modify Docket Text as appropriate
  - Click 'Next'
- 8. The Final Docket Text screen displays:**
  - Verify the Final Docket Text
  - Click Next

**9. The Notice of Electronic Filing screen display.**

(Refer to Notice of Electronic Filing for complete instructions).

**FILE A PROOF OF CLAIM**

[Administrative Order 03-02, Exhibit B \(II\),\(A\)](#), to the Electronic Case Filing Procedures states that each proof of claim PDF file must conform to Official Form 10 with respect to the information requested by that form and must include the following statement:

“Penalty for presenting fraudulent claim: ‘fine of up to \$500,000 or imprisonment up to 5 years or both.’ 18 U.S.C.§ 152 and 3571.”

Exhibit B, Section II C also provides guidelines for attachments to claim, which should be excerpted so as to include only the portion minimally necessary to support the claim. Only those portions of documents should be attached as exhibits to the claim that evidence the amount of the claim and demonstrate the claimant’s interest.

**STEPS**

**1. Click 'Bankruptcy' on the Blue Menu Bar:**

- Select Claims: File a Proof of Claim

**2. The Creditor Search screen displays:**

- Enter the case number
- Select the appropriate type of creditor from the drop-down list
- Click 'Next'

**3. Select a Creditor for Claim screen displays:**

- Click the drop-down arrow to display a list of creditors. Highlight the appropriate creditor.
- If the Creditor is not listed, click Add Creditor, proceed to Step 9, or
- If the Creditor is listed but needs a correction- Click 'Edit Creditor', Proceed to Step 7.
- Click 'Next'

**4. Proof of Claim Information screen displays:**

- Enter the Proof of Claim information

- Complete the 'Amount Claimed' fields. Do not use dollar signs or commons, etc.
  - You may enter a brief description in the description field or remarks in the remarks field
  - Click 'Next'
- 5. The PDF Selection screen displays:**
- Click 'Browse' (Refer to Navigating through Directories for complete instructions.)
  - Click 'Next'
- 6. The Notice of Electronic Filing screen displays:**  
(Refer to Notice of Electronic Filing for complete instructions.)
- 7. The Edit Creditor(s) screen displays:**
- Enter the name of the creditors last name or business, or
  - Click next to select to select the name from the entire list
  - The radio button defaults to Edit Creditor
  - Enter the correct information
  - Select the appropriate creditor type from the drop down menu
  - Creditor committee radio default to "N" do not change
  - Click 'Submit'
- 8. Modification is Completed message screen displays:**
- Click File a Proof of Claim
  - Return to Step 2
- 9. The Add Creditor(s) Screen displays:**
- **NOTE:** More than one creditor may be added by separating each creditor with a blank line
  - Enter the creditor's name and address
  - Select the appropriate Type from the drop-down menu
  - Creditor committee radio button defaults to "No" do not change
  - Click 'Next'
  - Total Creditors Entered with the number added will appear
  - Click 'Submit'

10. **Click 'File a Proof of Claim'**
  - Return to Step 2

## **FILE AN AMENDED PROOF OF CLAIM**

[Administrative Order 03-02, Exhibit B \(II\),\(A\)](#), to the Electronic Case Filing Procedures states that each proof of claim PDF file must conform to Official Form 10 with respect to the information requested by that form and must include the following statement:

"Penalty for presenting fraudulent claim: 'fine of up to \$500,000 or imprisonment up to 5 years or both.' 18 U.S.C. § 152 and 3571."

Exhibit B, Section II C also provides guidelines for attachments to claim, which should only excerpt the critical portions of documents filed as exhibits to the claim which evidence the amount of the claim and demonstrate the claimant's interest.

**NOTE:** Before beginning the docketing process you must obtain the claim number of the claim you are amending.

### STEPS

1. **Click 'Bankruptcy' on the Blue Menu Bar:**
  - Select 'Claims: File a Proof of Claim'.
2. **The Creditor Search screen displays:**
  - Enter the case number
  - Select the appropriate type of creditor from the drop down list
  - Click 'Next'
3. **Select a Creditor for Claim screen displays:**
  - A list of all Creditors displays, highlight the appropriate creditor.
  - If the Creditor is not on the list, Click Add Creditor, proceed to Step 9, or
  - If the Creditor is listed, but needs a correction, Click 'Edit Creditor', Proceed to Step 7.
  - Click 'Next'

4. **Proof of Claim Information screen displays:**
  - Click 'Find' next to the Amends Claim # box.
  - Click on the appropriate claim number. The number will then appear in the Amends Claim # box.
  - The claim amounts will automatically populate the fields.
  - Select 'Clear all Amounts' or change the amounts as needed. Do not use dollar signs or commons, etc.
  - You may enter a brief description in the description field or remarks in the remarks field.
  - Click 'Next'
5. **The PDF Selection screen displays:**



### AFFIDAVIT OF ADEQUATE PROTECTION AND LEASE PAYMENTS

Under BAPCPA and pursuant to [LBR 3015-3](#), any pre-confirmation adequate protection and personal property lease payments made pursuant to [11 U.S.C. § 1326\(a\)\(1\)](#) must be

disclosed. LBR 3015-3 requires that such payments shall be paid directly by the debtor(s) to the creditor rather than the chapter 13 trustee.

No later than fourteen (14) days prior to the date of a confirmation hearing, the debtor shall file with the Court an affidavit that discloses any Section 1326(a)(1) pre-confirmation payments paid by the debtor directly to creditors. The affidavit shall identify each creditor, the creditor's address, the last four digits of the account number, the date of payment, the due date of the payment, the amount of each payment and the aggregate amount of payments made pre-confirmation.

A copy of the affidavit shall be served on each creditor listed in the affidavit and upon the Chapter 13 trustee. In addition to the service required by Federal Rules of Bankruptcy Procedure 7004(b) and 9014, the debtor must serve a copy of the affidavit on the creditor in care of an individual at the creditor's address indicated on any proof of claim filed by that creditor and certify that service to the Court.



## SUMMONS PROCEDURES

When the court docket the "Summons Issued" event, you will receive a notice of electronic filing with a link to the summons. You will need to open the link to receive your copy of the summons to serve on all opposing parties. This copy replaces the hard copy summons which the court mailed to you in the past. This applies to both Involuntary Bankruptcy Cases as well as Adversary Proceedings (Complaints).

After completion of service, electronically file your pleading by selecting "Affidavit of Summons Service". Please contact the [case administrator](#) if you have any questions.

## ORDERS



### **SUBMISSION AND FORM OF PROPOSED ORDERS**

- Do not enter a proposed order on the docket.
- All proposed orders must be attached to the appropriate document (docket entry) as an attachment (to allow for review by all interested parties), except for Consent Orders and Orders requested by chambers. These orders should be uploaded for review by the Judge using the 'Order Upload' event.
- Required Submission and Form - A proposed order must accompany all requests for relief. (except Motions to Dismiss; Motions to Convert; Motion for Relief from Stay and pleadings initiating adversary proceedings) Such orders shall be filed as an attachment to the pleading. (Refer to Attachments to Documents for complete instructions.)
- Case Caption & Title - The proposed order must contain the case caption and a specific title describing the nature and effect of the order.
- Stipulations and Consent Orders - Consent orders shall be circulated and signed conventionally. The original consent order bearing original signatures of the consenting parties shall be maintained by the Filing User until three (3) years after the bankruptcy case is closed. Attorneys submitting proposed consent orders must include the following certification of consent:

“I HEREBY CERTIFY that the terms of the copy of the consent order submitted to the court are identical to those set forth in the original

consent order; and the signatures represented by the /s/ \_\_\_\_\_ on the copy of the consent order submitted to the Court reference the signatures of consenting parties obtained on the original consent order.”

**All proposed orders must conform to the following specifications:**

- The top margin on the first page must be no less than three (3) inches.
- The names and addresses of all counsel or other parties in interest who should receive copies of the order shall be set forth in the lower left-hand corner of the final page of the proposed order.
- The last line in the proposed order must state “End of Order,” and be centered in the middle of the line to indicate the end of the order.
- Do not include blank date lines or a signature line for the judge. The judge will electronically sign the document in the blank space provided by the top margin on the first page.
- Multi-page orders must contain page numbers at the bottom of each page.
- The only fonts that are to be used with Adobe Acrobat Writer version 3 or 4 are Courier, Helvetica, or Times New Roman (regular, bold, italic, and bold italic). The fonts used with Adobe Acrobat Writer version 5 must be Arial, Courier, or Times New Roman (regular, bold, italic, and bold italic). Other fonts will not process correctly through the court’s noticing center.

**UPLOADING PROPOSED ORDERS**

Orders that are submitted other than with the pleading, such as consent orders and orders embodying a ruling, shall be uploaded directly into the court’s e-order system. See the section on [Proposed Orders](#) for Required Submission and Form.

Please add 'uscourt.gov' to your pop-up blocker settings to allow pop-up's in CM/ECF. A temporary solution is to disable your pop-up blocker completely when docketing.

## **CLEARING TEMPORARY FILES/CACHE**

### **Overview**

The ECF system is a web-based software program. Users access ECF through a web browser. In order for information to be displayed properly in ECF it is necessary to clear the "cache" or temporary files that are stored on your PC. The cache should be cleared frequently to avoid errors.

Browser versions are updated frequently. The steps to clear cache may change with updated versions. The instructions below may not work for your version. You may need to Google the steps for the current version of your browser.

### **AOL**

- Click 'Settings', select 'Internet (Web) Options'
- The AOL 'Internet Properties' box will open
- Under 'Temporary Internet Files', click on 'Delete Cookies'
- Under 'History', 'Click on Clear History'
- Click 'OK' to exit
- Click 'Settings', select 'Internet (Web) Options'
- The AOL 'Internet Properties' box will open
- Under 'Temporary Internet Files', click on 'Delete Files'
- Under 'History', 'Click on Clear History'
- Click 'OK' to exit

### **Firefox**

- Open Firefox and click on 'Tools'
- Click on Clear Recent History

- Select 'Everything' in the 'Time Range' section
- Click on 'Details' and select 'Cache' (you may also select 'Cookies')
- Click on the 'Clear Now' button

Firefox has an option to clear Cache automatically when you close the browser. Go to 'Tools' and click on 'Option'. Select the 'Privacy' tab and check the 'Clear history when Firefox closes' checkbox. Click the 'Settings' button to specify what you want deleted.

### **Internet Explorer**

- Open Internet Explorer and click on 'Tools'
- Then click on Delete Browsing History...
- Check the Temporary Internet Files and Cookies

Internet Explorer has an option to automatically clear temporary internet files and cache every time you close the browser. To enable it click on the 'Advanced' tab, find the 'Security' section and check the box next to 'Empty Temporary Internet Files When the Browser is Closed'.

### **Google Chrome**

- Open Chrome and click the 'Tools' menu in the upper-right corner
- Select 'Options'
- Select the 'Under the Hood' tab, click on 'Clear Browsing Data'
- Check the 'Empty the cache' checkbox
- Select the time range from the drop-down menu. We recommend selecting 'everything'
- Click the 'Clear Browsing Data' button and you're done

### **Safari**

- From the Safari Menu, click 'Empty Cache'
- When asked 'Are you sure you want to empty the cache?', click 'Empty'
- From the Safari Menu, click 'Preferences'
- From the Security dialog box, click 'Bookmarks'
- Click 'Show Cookies'
- Click 'Remove All'

## HOW TO CONVERT A DOCUMENT TO PDF/A

### STEPS

1. **Create a document in your word processing software.**
2. **Click 'File' in the toolbar and select 'Print'**
  - Click the down arrow on the 'Select printer:' field
  - Select "Acrobat PDFWriter or Publish To (Select PDF) from the drop-down menu
  - Click 'Print'
3. **Select the directory where the PDF/A file will be saved.**
  - Enter the Name of the Document in the 'File Name' field
  - Click 'Save'

### Scanning a Document to a PDF/A

Please note that [Administrative Order 11-03](#) directs all filers to convert those documents that are created by the attorney directly to PDF. Only those documents that you did not create can be scanned into PDF/A. Each scanning program and software will vary. Your scanner must be set to black and white and 300 DPI and set to scan to PDF/A to comply with National Archives & Records Administration (NARA) document preservation standards. Please refer to your scanner manual and software for specifics with your setup.

## HOW TO CONVERT A CREDITOR MATRIX TO A TEXT (.TXT) FILE

The following instructions will guide you to correctly format a creditor matrix and save it as a.txt file. A creditor matrix contains each creditor's name and mailing address. This information is used for noticing and also for claims information when applicable. The creditor matrix must be in an ASCII file format with an appropriate text extension such as .txt before it can be successfully uploaded into the CM/ECF system.

### Suggested Creditor Matrix Specifications:

- The name and address of each creditor cannot be more than 5 lines. If a record is more than 5 lines, the 6th line will be combined with line 5 and the 7th or 8th will be truncated.

- Each line may contain no more than 50 characters for a name and no more than 40 for an address including blanks.
- Names and addresses must be left justified. **Note:** If the address is foreign a country, enter the name of the country as the LAST line of the address.
- Spaces in the first position of a line will cause problems.
- Special characters such as ~, ½ or ^ will cause problems a & must have a space before and after the character. The # and other characters have not been reported to cause errors.
- City, state and Zip code must be on the last line. (See note above regarding foreign addresses).
- Nine-digit Zip codes must be typed with a hyphen separating the two groups of digits.
- All states must be two-letter abbreviations
- Each creditor must be separated by at least one blank line.
- Do not include page numbers, headers, footers, etc.

#### **Save the Creditor Matrix File with a .txt Extension -**

1. **After creating the list in WordPerfect or Microsoft Word, open the file.**
2. **Click 'Save As' in the drop-down list.**  
If in Microsoft Word, Skip to Step 4.  
If in WordPerfect: continue to Step 3.
3. **Word Perfect:**
  - Click the Drop-down menu arrow in the File Type box
  - Select the type ASCII DOS Text
  - Click on Save.
4. **Microsoft Word:**
  - Click the drop-down box in the Save As Type box
  - Select the type of Text Files (\*.txt) or Text Only (\*.txt).
5. **Enter the file name in the 'File Name:' text box.**
6. **Click 'Save'**


## NAVIGATING THROUGH FOLDERS

Prior to beginning the docketing process, create your document and convert it to a PDF format. (Refer to the [How to Convert a Document to a PDF/A](#) for complete instructions.) It is very important to know the location of the saved document. For easy access when filing your documents with the court, you may want to establish a file folder and/or a directory for saving your documents.


### STEPS

1. **During the docketing process the 'Select the pdf document displays':**

- Click 'Browse' to attach the primary document.




- A window will appear that allows you to navigate through directories (also called folders) to select a specific file.
- If the "Choose file window" doesn't default to the correct drive, click the down arrow at the "Look in" screen to locate the drive/folder where the document was saved.

- You should always view your PDF image to ensure you are selecting the correct one.
- To view the document, right-click on the document, select 'Open' to view the document, if the PDF is correct close out of the document.
- You will return to the screen “Choose file” screen with the document highlighted.



- Click the 'Open' button to add your document address in the CM/ECF 'Browse' field and return to docketing process.

2. **Additional Attachments (if necessary)**
